1. You may have access to the party area **1 hour** (part of 3.5 hr. time slot) prior to the start time of your party for setup. Please do not arrive early.
2. You must vacate the area promptly at the ending time of your party to allow our staff to prepare for our next guests. Any guests remaining beyond 30 minutes past their party end time will be charged \$25 for each additional 15 minutes. Please place all trash in receptacles and leave area in reasonably clean condition. We will wipe tables.
3. We will provide 1-2 parking spaces inside our main gates in front of our home for the host. Additional parking spaces are available for guest just outside our main gates on the street next to our property.
4. As party host, you are responsible for any damages to our property, animals or attractions caused by your guest.
5. Parties are held regardless of weather conditions. In the event of rain, we will reschedule the party with your schedule in mind.
6. **Party format is as follows:** 1 hr. for set-up & decorating, 2<sup>nd</sup> hour Guest Check in and sign waivers, guest gather in party area visiting and eating, pony and/or horse rides and petting zoo animal areas open to guest, 3<sup>rd</sup> hour guest continue to visit in party area enjoying food, cake, goodies and presents (per host discretion) etc. Last ½ hour is given for cleanup.
7. A \$100.00 non-refundable deposit is required with your reservation. The balance is due on the day of your party. We accept Cash, Venmo-@christina-Dingle-1 (last 4 digits of phone # 7294) zelle-925-383-2221 (Jason Dingle) and checks written to Christina Dingle.
8. To assure your reservation PLEASE SIGN ONE COPY OF THIS AGREEMENT (or Invoice) AND RETURN IT WITH YOUR DEPOSIT to guarantee your party date. Deposits must be received

9. We allow taco carts & caterers onsite with advance notice and our approval.
10. **Included-Shaded Party Area-** 4 Picnic Tables (30"x6), 2 Serving Tables (2'x8'), 4 Spool Tables (4' dia. round), 2 (30") Galvanized tubs for cold drinks and heaters (for colder months) **Lawn-Lawn Games, Services-** Staff will assist the host with carrying items to and from the party area and upon request refrigeration for cake or cupcakes is available.
11. **Absolutely no alcohol, smoking, vaping, BBQing or Fires will be permitted on the farm property at any time!**
12. Please do not bring table confetti as it is dangerous to our animals. Balloons must be safely secured and will be allowed per our discretion for the safety of the animals and their riders.
13. Please remind your guest to wear closed toe shoes. Please have all guest who are planning to ride a pony to wear pants as well, jeans preferred.
14. The standard party rate includes 20 children and no more than 60 guest maximum.
